RULES & REGULATIONS

1. No fee will be charged for regular league play.
2. No fee will be charged for Walcott Little League sponsored tournaments.
3. The person or organization will be responsible to enforce the rules and regulations, including chapter 47 of the Walcott Code of Ordinances.
4. No fields will be in use after 11:00 p.m. (park closing time), unless it is for the annual IAISC fast-pitch softball tournament. During the IAISC tournament, no games will be started later than 11:00 p.m., and the parks shall close immediately at the conclusion of the game.
5. After use, all equipment shall be put away and all lights shall be turned off.
6. The person or organization will be responsible for filling in all holes and chalking of the field.
7. Any special dragging of diamonds, outside of the regular schedule established by the Walcott Public Works Director, shall be approved by the Public Works Director.
8. Groups renting the fields are responsible for cleaning the fields, restrooms, spectator areas, and parking areas of litter.
9. Those renting the facilities for tournaments must show that they have proper insurance coverage.

The above listed party hereby agrees to the following:

- I (we) shall immediately reimburse the City for any damages that may occur to the ball field and/or surrounding area arising out of the use of the ball field and/or surrounding area during the time that the ball field is reserved for tournament use.
- I (we) shall at all times adhere to the rules, regulations and laws of the City of Walcott and the State of Iowa which govern such activities and/or use of said public property.

Further, the above listed party and any person(s) claiming through or under the undersigned, covenant and agree to protect, indemnify, and hold harmless the CITY OF WALCOTT, IA, its departments, agents, employees, and assigns from any and all actions, claims, demands for damages, expenses, (including attorney's fees), or liability of any kind or nature whatsoever, which may be occasioned by or arising out of any accident or other occurrence causing or inflicting injury and/or damage to any person(s) or injury and/or damage to property, which may result from the use of a ball diamond and the surrounding park grounds.
